# **OFFICIAL CONTEST RULES**

# SAMSUNG "FLIP MY DORM" CONTEST (THE "CONTEST")

# THE CONTEST IS SPONSORED BY SAMSUNG ELECTRONICS CANADA INC. ("SPONSOR"), 2050 DERRY ROAD WEST, MISSISSAUGA, ON L5N 0B9. THE CONTEST IS ADMINISTERED BY MOSAIC SALES SOLUTIONS OPERATING CO. ("ADMINISTRATOR"), 100 LIBERTY STREET TORONTO, ON M6K 3L7.

No purchase necessary to enter or win. Void where prohibited. This Contest will run in accordance with these Rules. The Sponsor reserves the right, subject to any required approval of any regulatory authorities, to cancel, amend, modify or terminate this Contest or these Official Rules at any time in its sole discretion and without further notice. Changes to these rules will be posted online at samsung.com/ca/flipmydorm. You must comply with these Official Rules and by participating in the Contest, you hereby agree to these Official Rules.

# A. ENTRY DATE:

The Contest begins at 12:00:01 a.m. Eastern Standard Time ("**EST**") on Monday, August 21, 2023 and ends at 11:59:59 p.m. EST on Saturday, September 30, 2023 ("**Contest Entry Period**").

# B. ELIGIBILITY:

The Contest is open to legal residents of Canada, (excluding residents of Québec), between the ages of 16 and 27 years of age and currently attending a recognised post-secondary educational institution in Canada (excluding post-secondary institutions located or registered in Québec). Where you have not yet reached the age of majority in your province or territory of residence, you must have the consent of a parent or legal guardian to participate in the Contest. Employees of the Sponsor or the Administrator, not-for-profit organizations that are supporting the Sponsor or Administrator with the promotion, and each of their respective parents, affiliates, subsidiaries, advertising and promotion agencies, retailers, distributors and suppliers (collectively the "Contest Entities"), and the immediate families (spouse, parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same households of any of the foregoing individuals, whether or not related, are ineligible to participate or win a prize. Subject to all applicable federal, provincial and local laws and regulations.

# C. HOW TO ENTER:

To enter, proceed to samsung.com/ca/flipmydorm. Participants are required to capture and post a video of up to 30 seconds explaining how Samsung Galaxy products would upgrade their student life. There are two ways to submit entry to the Contest ; via Social Account or via Cloud Storage Account.The video must be posted to a social media or cloud storage account owned and controlled by the participant, this includes: Instagram, Facebook (Meta), Tiktok, Twitter (X), YouTube, Google Drive, WeTransfer or Dropbox. The participant is required to submit the URL of the video (the

"**Contestant-Generated Content**") on the samsung.com/ca/flipmydorm website during the Contest Entry Period and in the correct specifications as outlined below.

# Steps for Entry via Social Account:

- 1. Record a video of up to 30 seconds explaining how Samsung Galaxy products currently or would upgrade your student life.
  - a. The video must adhere to these Contest Rules.
- 2. Proceed to upload the video during the Contest Entry Period on any of your social accounts, this includes: Instagram, Facebook (Meta), Tiktok, Twitter (X), or YouTube. The Participant must tag @SamsungCanada and use the hashtag #FlipMyDorm and #SamsungContest.
  - a. Posts made on Private accounts will not be eligible.

  - c. Go to samsung.com/ca/flipmydorm to complete the entry form and submit the URL of the finished and published video.
  - d. The URL must be accessible on a Public social media profile.
  - e. If you are under the age of majority in your province or territory, you will additionally need to provide a signed parental/guardian consent form, as found on samsung.com/ca/flipmydorm.

# **Steps for Entry via Cloud Storage Account:**

- 1. Record a video of up to 30 seconds explaining how Samsung Galaxy products currently or would upgrade your student life.
  - a. The video must adhere to these Contest Rules.
- 2. Proceed to upload the video during the Contest Entry Period on any of your cloud storage account, this includes: Google Drive, WeTransfer, or Dropbox.
  - a. It is free to make an account on Google Drive, WeTransfer. Please visit the respective website for more information:

  - b. Go to samsung.com/ca/flipmydorm to complete the entry form and submit the URL of the finished and uploaded video.
  - c. The URL must be accessible to the recipients until October 20<sup>th</sup>, 2023 or the winners are announced by the Sponsor, whichever is sooner.
  - d. If you are under the age of majority in your province or territory, you will additionally need to provide a signed parental/guardian consent form, as found on samsung.com/ca/flipmydorm.

There is a limit of **one (1)** entry per person. If you exceed the permitted number of entries per person, you will be disqualified. Entries must be received before the Contest Period expires. Each fully completed entry will be an "entry" for purposes of the Contest, and only fully completed entries will be accepted and eligible for entry into the Contest. Entries that are in any way fraudulent, illegible, altered, mutilated or tampered with, in the sole discretion of the Contest Sponsor, will be declared invalid.

Your Contestant-Generated Content must never have been previously exhibited publicly outside of this Contest or selected as a winner in any other Contest. To be eligible for entry in this Contest, your Contestant-Generated Content must meet the following specific requirements:

- 1. The Contestant-Generated Content must be in video format
- 2. The Contestant-Generated Content must not exceed 30 seconds in length;
- 3. The video adheres to the Representations and Warranties as outlined below in section G, as well as the remainder of these Rules.

BY SUBMITTING AN ENTRY, YOU AGREE THAT THE CONTESTANT-GENERATED CONTENT COMPLIES WITH ALL CONDITIONS STATED IN THESE RULES. THE RELEASED PARTIES (AS DEFINED BELOW) WILL BEAR NO LEGAL LIABILITY, EXPRESSED OR IMPLIED, REGARDING THE USE OF THE CONTESTANT-GENERATED CONTENT BY THE CONTEST SPONSOR. THE RELEASED PARTIES SHALL BE HELD HARMLESS BY YOU IN THE EVENT IT IS SUBSEQUENTLY DISCOVERED THAT YOU HAVE DEPARTED FROM OR NOT FULLY COMPLIED WITH ANY OF THE RULES.

#### D. PRIZES:

There are a total of three (3) prize packages available to be won (collectively, the "**Prizes**" and each individually a "**Prize**") each consisting of a Galaxy Prize Pack made up of a Galaxy Z Flip5 smartphone, a Galaxy Watch6 smartwatch, and a Galaxy Tab S9 Ultra (valued at approximately \$3,309.97 based on MSRP) each selected by the Sponsor.

The approximate retail value of each Prize, in Canadian dollars, is as follows: Galaxy Z Flip5 smartphone (\$1,299.99), Galaxy Watch6 smartwatch (\$409.99), and Galaxy Tab S9 Ultra (\$1,599.99), for a total Prize value of \$3309.97per Prize. Each Prize must be accepted as awarded without substitution, and is not redeemable for cash. A Prize may be substituted by the Contest Sponsor only with an alternate prize of equal or greater value in the Contest Sponsor's sole discretion, subject to any required regulatory approvals.

The Administrator will make three (3) attempts to contact you, if you are a selected contestant, by telephone or by email within seven (7) business days of the Contact Date (outlined below). If any email to a selected contestant is undeliverable, any phone number provided by a selected contestant is incorrect or no longer in service, a response to any given e-mail or phone call is not received within three (3) business days of date of its issuance, any selected contestant declines the prize, or any selected contestant does not comply with these Rules, the opportunity to win the Contest may be forfeited and, at Sponsor's sole discretion, an alternate contestant may be selected from all eligible entries in accordance with the Judging Criteria set out below. The process noted above will be

repeated until a selected contestant has been contacted and the Prize has been awarded in accordance with these Rules or Administrator runs out of eligible entries, whichever occurs first.

Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Sponsor or Administrator except for any manufacturer's warranty accompanying the Samsung products. Winners will be responsible for any expenses associated with acceptance and use of the prize except as expressly stated in these Official Rules. All prize details are at the sole discretion of the Sponsor.

Odds of winning depend upon the total number of eligible entries received during the Contest Entry Period and the quality of the submissions.

IF YOU ARE A SELECTED WINNER, YOU MUST, BEFORE BEING DECLARED A WINNER: (i) correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill testing question; and (ii) execute and deliver to the Administrator within the time specified by the Administrator a Declaration of Eligibility and Waiver of Liability Form (the "Waiver") in a form acceptable to the Sponsor, confirming your compliance with these Rules, acceptance of the Prize as awarded without substitution, and releasing the Sponsor, the Administrator, each of their affiliates and related third parties, advertising and promotional agencies, and each of their respective shareholders, directors, officers, employees, agents, dealers, representatives, successors and assigns (collectively the "Released Parties") from any liability in connection with this Contest, your participation therein and/or the awarding and use/misuse of the Prize or any portion thereof. If you are under the age of majority in your province or territory of residence, you must have a parent or legal guardian co-sign the Waiver in order to receive a Prize. All required documents must be executed and returned prior to receiving a Prize. Declining the Prize, failing to return one of the Administrator's attempts to contact you within the times noted above, failing to comply with these Rules, failing to correctly answer the mathematical skill testing question or failing to execute and deliver to the Administrator the Waiver within the specified time will cause the Prize to be forfeited by you and a new contestant will be selected by the Judges from the remaining eligible entries to select another contestant in accordance with the provisions noted above.

# If you are a selected contestant, the Prize will be delivered to your home address, as provided by you on the entry form, within 6-8 weeks following selection.

# E. JUDGING OF CONTESTANT-GENERATED CONTENT

All eligible entries received during the Contest Entry Period will be judged based on the following criteria by a panel of qualified judges selected by the Sponsor. The judging panel will consist of three (3) judges as chosen by the Sponsor and will consist of employees of the Sponsor. Entries will be viewed as videos and the contestant video URLs will be sent electronically via email to all judges and graded by the judge panel at the Sponsor's head office located at 2050 Derry Road West, Mississauga, Ontario, in accordance with a scorecard provided by the Sponsor that contains the criteria set out below. Judging will be completed on October 4 and October 5, 2023 and will be based on the following criteria:

• 50% Originality and Uniqueness of the Video

- 30% Integration of Samsung Galaxy Branding and Features
- 20% Quality of submission

Subject to verification of eligibility and compliance with these Official Rules, a maximum of three (3) entries, with the highest scores will be deemed Winners. In the event of a tie based on the values provided by the judges in accordance with the scorecard set out above, an additional "tie-breaking" judge, as selected by the Sponsor, will determine the entrant to be selected as a Winner.

The judging of all Contestant-Generated Content will take place on October 4, 2023 and October 5, 2023. The three (3) Winners will be contacted by the Administrator on October 12th, 2023 (the "Contact Date"). The Winners will be announced on samsung.com/ca/flipmydorm on or about October 20th, 2023, provided that these Official Rules are complied with.

# F. YOUR REPRESENTATIONS AND WARRANTIES:

You represent and warrant that your Contestant-Generated Content:

- (a) is original and that you have or have obtained all necessary rights in and to the Contestant-Generated Content and all of its components to enter the Contestant-Generated Content in the Contest. For example, you must have permission to use any and all artwork, and photographs contained in the Contestant-Generated Content, as well as consent of the photographer, if applicable;
- (b) does not violate any law, statute, ordinance or regulation;
- (c) does not contain any reference to or likeness of any identifiable third parties, unless consent has been obtained from all such individuals (and their parental/legal guardian if they are under the age of majority in their jurisdiction of residence);

  - (iii) derogatory characterizations or generalizations of any ethnic, racial, sexual or religious groups;
  - (iv) content that endorses, condones or discusses any illegal, inappropriate or risky activity, behaviour or conduct;
  - (v) personal information of individuals, including without limitation, names and addresses (physical or e-mail);
  - (vi) photographs, images, or video clips of individuals unless consent has been obtained;

- (vii) photographs, images or video clips of a post-secondary institution's dormitory, student accommodation, or institution owned housing, nor in any other building owned by the post-secondary institution located on or off of their campus;
- (viii) conduct or other activities in violation of these Rules;
- (ix) commercial messages, claims, comparisons or solicitations for products or services, other than Samsung products or services;
- (x) any identifiable third party products and/or trade-marks, brands, logos or copyright. For example, any clothing worn by persons appearing in the Contestant-Generated Content must not contain any visible/identifiable logos, trade-marks or other third party materials, unless the necessary permissions/licenses have been obtained; and
- (xi) any other content that is or could be considered inappropriate, unsuitable or offensive, all as determined by the Contest Sponsor in its sole discretion.

# G. LICENCE TO USE CONTESTANT-GENERATED CONTENT

At any time during or subsequent to the Contest, the Sponsor may, in its sole discretion, modify, edit or remove any Contestant-Generated Content, or request that you modify or edit your Contestant-Generated Content, if a complaint is received with respect to the Contestant-Generated Content, or for any other reason.

# H. GENERAL CONDITIONS:

i. AGREEMENT: By entering the Contest and submitting Contestant-Generated Content, you agree to the publication, reproduction and/or other use of: (i) your name, city of residence, statements about the Contest, photograph or other likeness, social media handles, and any other information collected for the purposes of this contest; and (ii) the Contestant-Generated Content, without further notice or compensation, in any publicity or advertisement carried out by the Sponsor or its advertising and promotion agencies in any manner whatsoever, including print, broadcast or on the Internet.

This Contest is subject to all applicable federal, provincial, territorial, and municipal laws and regulations. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on you without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of entries.

The Sponsor reserves the right, in its sole discretion, to cancel or modify this Contest should the technological security, physical security or proper administration of the Contest be compromised for any reason.

iv. DISPUTES: In the event of a dispute regarding who submitted an entry, entries will be deemed to have been submitted by the authorized account holder of the telephone number submitted at the time of entry. "Authorized account holder" is defined as the person who is assigned a telephone number by a telephone service provider or other organization (e.g. business, educational institute, etc.) that is responsible for assigning telephone numbers. You may be required to provide proof that you are the authorized account holder of the telephone number associated with the selected entry and that you have all necessary consents, permissions and/or licenses as required by these Rules. The sole determinant of the time for the purposes of a valid entry in this Contest will be the Contest server machine(s). All entries are subject to verification by the Sponsor in its sole discretion. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form

acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification. You may also be required to provide proof that you are the contestant in respect of the selected entry. The Sponsor reserves the right, in its sole discretion, to disqualify any individual (and all of their entries) who tampers with the entry process.
