

## OFFICIAL CONTEST RULES

### SAMSUNG GALAXY TAB S10+ GIVEAWAY (THE "CONTEST")

**THE CONTEST IS SPONSORED AND ADMINISTREED BY SAMSUNG ELECTRONICS CANADA INC. ("SPONSOR"), 2050 DERRY ROAD WEST, MISSISSAUGA, ON L5N 0B9.**

No purchase necessary to enter or win. Void where prohibited. This Contest will run in accordance with these Rules. The Sponsor reserves the right, subject to any required approval of any regulatory authorities, to cancel, amend, modify or terminate this Contest or these Official Rules at any time in its sole discretion and without further notice. #### **A. ENTRY DATE:**

CONTEST BEGINS ON TUESDAY NOVEMBER 12, 2024 AT 9:00AM (EDT) AND ENDS ON TUESDAY DECEMBER 3, 2024 AT 11:59 PM (EDT) (EDT) (THE "CONTEST PERIOD").

#### **B. ELIGIBILITY:**

No purchase necessary. Void where prohibited. The Contest is open only to legal residents of Canada who are twenty one (21) years of age or older and are currently employed as full-time teachers in a public Middle School, Junior High School, or High School, grades 6-12, including Charter Schools that are 50% or more publicly funded in Canada (each a "Teacher") who have submitted a valid application to enter the Samsung Canada "Solve for Tomorrow" 2024/2025 Education Contest (the "Solve for Tomorrow Contest"), as per the Official Solve for Tomorrow Contest Rules, found here: [https://pages.samsung.com/ca/solvefortomorrow/English/SFT\\_RulesRegs\\_2024\\_2025\\_EN.pdf](https://pages.samsung.com/ca/solvefortomorrow/English/SFT_RulesRegs_2024_2025_EN.pdf).

Employees of the Sponsor, not-for-profit organizations that are supporting the Sponsor with the promotion, and each of their respective parents, affiliates, subsidiaries, advertising and promotion agencies, retailers, distributors and suppliers (collectively the "Contest Entities"), and the immediate families (spouse, parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same households of any of the foregoing individuals, whether or not related, are ineligible to participate or win a prize. The Contest is subject to all applicable federal, provincial and local laws and regulations.

#### **C. HOW TO ENTER:**

To enter into the Contest, you must complete **all** of the steps noted below:

2. As part of the application submission process for the Solve for Tomorrow Contest, enter and submit the mandatory information requested, including your first name, last name, email address, school contact information, and select the checkbox indicating that you wish to participate in this Contest

Each entry must be submitted during the Contest Period. There is a limit of one (1) entry per Teacher, as applicable. Entries that are in any way duplicated, fraudulent, illegible, altered, mutilated or tampered with, or that contains any computer viruses, worms or other potentially damaging computer programs or files, in the sole discretion of the Contest Sponsor, will be declared invalid.

#### **D. PRIZES:**

There is a total of 10 prizes (each, a “Prize”), each consisting of one (1) Galaxy Tab S10+ – 256GB (approximate retail value of CDN \$999.99).

The Prize must be accepted as awarded without substitution, and is not redeemable for cash. The Prize will be awarded to the individual Teacher who has entered the Contest, not their respective school. The Prize may be substituted by the Contest Sponsor only with an alternate prize of equal or greater value in the Contest Sponsor’s sole discretion, subject to any required regulatory approvals.

#### **E. DRAW OF CONTEST WINNERS**

Ten (10) winners will be determined through a randomized draw of all the eligible entries submitted during the Contest Period, on Friday, December 6, 2024 at 9:00 AM EST (the “Draw Date”) at the Sponsor’s head office located at 2050 Derry Road West, Mississauga, Ontario.

If you are determined by the Contest Sponsor, in the Contest Sponsor's sole discretion, to have failed to comply with these Contest Rules, you will be disqualified from the Contest and all related entries shall be deemed null and void. Odds of winning depend upon the total number of eligible entries received during the Contest Period.

#### **F. SELECTING THE CONTEST WINNERS**

The Sponsor will make three (3) attempts to contact you, if you are a selected contestant, by telephone or by email within seven (7) business days of the Draw Date. If you cannot be contacted within three (3) attempts or seven (7) business days of the Draw Date (whichever occurs first), or if you decline the Prize, then you will be disqualified and an alternate contestant will be randomly selected from among the remaining eligible entries. The process noted above will be repeated until a selected contestant has been contacted and the Prize has been awarded in accordance with these Rules or Contest Sponsor runs out of eligible entries, whichever occurs first.

Prizes are awarded “as is” with no warranty or guarantee, either express or implied, by Sponsor or Sponsor except for any manufacturer’s warranty accompanying the Samsung products. Winners will be responsible for any expenses associated with acceptance and use of the prize except as expressly stated in these Official Rules. - iv. **DISPUTES:** In the event of a dispute regarding who submitted an entry, entries will be deemed to have been submitted by the authorized account holder of the telephone number submitted at the time of entry. “**Authorized account holder**” is defined as the person who is assigned a telephone number by a telephone service provider or other organization (e.g. business, educational institute, etc.) that is responsible for assigning telephone numbers. You may be required to provide proof that you are the authorized account holder of the telephone number associated with the selected entry and that you have all necessary consents, permissions and/or licenses as required by these Rules. The sole determinant of the time for the purposes of a valid entry in this Contest will be the Contest server machine(s). All entries are subject to verification by the Sponsor in its sole discretion. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest.
