

## OFFICIAL CONTEST RULES

### SAMSUNG GALAXY TAB S10 FE GIVEAWAY (THE "CONTEST")

**THE CONTEST IS SPONSORED AND ADMINISTREED BY SAMSUNG ELECTRONICS CANADA INC. ("SPONSOR"), 2050 DERRY ROAD WEST, MISSISSAUGA, ON L5N 0B9. THE CONTEST IS ADMINISTERED BY CHEIL USA, INC. ("ADMINISTRATOR"), 6790 CENTURY AVE #100, MISSISSAUGA, ON L5N 2V8.**

No purchase necessary to enter or win. Void where prohibited. #### **A. ENTRY DATE:**

SOLVE FOR TOMORROW ENTRY FORM CONTEST BEGINS ON MONDAY, JANUARY 12, 2026 AT 9:00AM (EDT) AND ENDS ON FRIDAY FEBRUARY 27, 2026 AT 11:59 PM (EDT) (THE "CONTEST PERIOD").

#### **B. ELIGIBILITY:**

The Contest is open only to legal residents of Canada who are twenty one (21) years of age or older and are currently employed as full-time teachers in a public Middle School, Junior High School, or High School, grades 6-12, including Charter Schools that are 50% or more publicly funded in Canada. All Canadian publicly funded schools are eligible to participate. Schools that are publicly funded but outside of the provincially-run school board/district/division system, such as Charter Schools in Alberta and Federally-funded schools in FNMI communities, are eligible to apply if they meet the grade requirements. Home School, privately funded Charter school (less than 50% publicly funded), Private School, College, University, and Vocational/Trade School teachers are not eligible to participate. A full-time teacher, as defined above, is eligible to enter the Contest as part of a team with at least one (1) or more students, up to a maximum of fifty (50) students (the "Participant"). Each Participant is entering on behalf of their school.

Employees of the Sponsor, not-for-profit organizations that are supporting the Sponsor with the promotion, and each of their respective parents, affiliates, subsidiaries, advertising and promotion agencies, Administrator, retailers, distributors and suppliers (collectively the "Contest Entities"), and the immediate families (spouse, parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same households of any of the foregoing individuals, whether or not related, are ineligible to participate or win a prize. The Contest is subject to all

applicable federal, provincial and local laws and regulations.

### C. HOW TO ENTER:

To enter into the Contest, you must complete all of the steps noted below:

As part of completing the Solve for Tomorrow Contest registration, enter and submit the mandatory information requested, including your first name, last name, school name, grade, school contact information (official school email), teacher ID, number of students on your team (team size), choice of theme, students' proposed STEM solution to challenge identified, and how your student's STEM solution will be successful. All entries must adhere to the Solve for Tomorrow contest rules. Each entry must be submitted during the Contest Period. Entries that are in any way duplicated, fraudulent, illegible, altered, mutilated or tampered with, or that contains any computer viruses, worms or other potentially damaging computer programs or files, in the sole discretion of the Contest Sponsor, will be declared invalid.

### D. PRIZES:

There is a total of seven (7) prizes (each, a "Prize"), each consisting of ten (10) Galaxy Tab S10 FE – 128GB devices (each with an approximate retail value of CDN \$ \$699.99 MSRP + tax).

ENTRY NOTE: Participants are responsible for confirming whether their school has any policies or restrictions concerning participation in contests such as this. The awarding of prizes is subject to such school policies. If, for any reason, any school is unable to accept a prize, including due to school policies, such prize will be forfeited and Sponsor will not have any further obligation to such school.

PRIZE NOTE: **Each Prize will be awarded to the winning school for the benefit of the winning school and not the Participant.** Winning schools will be responsible for all taxes, if any (including federal, provincial and local taxes) and other costs and expenses associated with the acceptance and use of a prize (or any portion thereof) not included with the prize as awarded, including, but not limited to, installation and costs of any service, including any telephone or cable service.

All prizes awarded pursuant to this Contest are awarded "as is" with no warranty or guarantee, either express or implied, by Sponsor except for any manufacturer's warranty accompanying the Samsung products. Prizes will be awarded to the selected contestants/finalists/winners' school for the benefit of the applicable selected contestants/finalists/winners. Notwithstanding anything contained herein, Sponsor reserves the right to not award all prizes or advance fewer entries for any phase of the Contest if, in its sole discretion, it determines it has not received a sufficient number of qualified eligible entries.

#### **E. DRAW OF CONTEST WINNERS**

Seven (7) winning schools will be determined through a randomized draw of all the eligible entries submitted during the Contest Period, on Friday, May 15, 2026 at 9:00 AM EST (the “Draw Date”) at the Sponsor’s head office located at 2050 Derry Road West, Mississauga, Ontario. Each winning school will receive one (1) Prize, consisting of ten (10) Galaxy Tab S10 FE – 128GB devices (each with an approximate retail value of CDN \$699.99 MSRP + tax).

If you are determined by the Contest Sponsor, in the Contest Sponsor's sole discretion, to have failed to comply with these Contest Rules, you will be disqualified from the Contest and all related entries shall be deemed null and void. Odds of winning depend upon the total number of eligible entries received during the Contest Period.

#### **F. SELECTING THE CONTEST WINNERS**

The Sponsor will make three (3) attempts to contact the teacher representative of the winning school, if you are a selected contestant, by telephone or by email within seven (7) business days of the Draw Date. If you cannot be contacted within three (3) attempts or seven (7) business days of the Draw Date (whichever occurs first), or if you decline the Prize, then you will be disqualified and an alternate contestant will be randomly selected from among the remaining eligible entries. The process noted above will be repeated until a selected contestant has been contacted and the Prize has been awarded in accordance with these Rules or Contest Sponsor runs out of eligible entries, whichever occurs first.

Prizes are awarded “as is” with no warranty or guarantee, either express or implied, by Sponsor or Sponsor except for any manufacturer’s warranty accompanying the Samsung products. Winners will be responsible for any expenses associated with acceptance and use of the prize except as expressly stated in these Official Rules. All prize details are at the sole discretion of the Sponsor.

- iv. **DISPUTES:** In the event of a dispute regarding who submitted an entry, entries will be deemed to have been submitted by the authorized account holder of the telephone number submitted at the time of entry. “**Authorized account holder**” is defined as the person who is assigned a telephone number by a telephone service provider or other organization (e.g. business, educational institute, etc.) that is responsible for assigning telephone numbers. You may be required to provide proof that you are the authorized account holder of the telephone number associated with the selected entry and that you have all necessary consents, permissions and/or licenses as required by these Rules. The sole determinant of the time for the purposes of a valid entry in this Contest will be the Contest server machine(s). All entries are subject to verification by the Sponsor in its sole discretion. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest.
